As a Diverse Communities Outreach Worker, your job will be to provide high quality support, risk assessment, information and advocacy to clients from Black, Asian or Minoritised Communities who have experienced domestic abuse. The role, funded by the National Lottery, is intended to undertake active engagement work with community organisations and individuals, raising awareness of domestic abuse, BWA services and reducing barriers for survivors who may find it harder to access services. Your role is to empower our clients, keeping the safety of them and their children central to our interventions. We are looking for an individual who is able to work in a fast-paced environment and is committed to building strong relationships with a wide range of professional agencies.

### What will you do?

---

1. Work as part of the S.A.F.E Outreach team, BWA staff, volunteers and colleagues to provide culturally sensitive outreach support, advocacy, group facilitation and professional training.
2. Work in partnership with voluntary and statutory organisations, maintaining good working relationships with external agencies and keeping up to date with local resources and services available to clients.
3. Meet or speak on the telephone with victims of domestic abuse, 'honour' based abuse or forced marriage to provide support and information, providing a full initial assessment to clients to identify and address their needs.
4. Provide appropriate crisis support to outreach clients, completing assessments of risk and undertaking high quality safety and support planning, signposting and referring clients to external agencies and other specialist services as required.
5. Attend meetings as and when necessary to support clients with Child Protection processes, housing needs or the criminal and civil justice systems.
6. Support the BWA Helpline or Triage Worker if required, take calls and provide confidential advice, helping to arrange safe accommodation and transport for clients and their children.
7. Complete a local mapping exercise to identify local community organisations and make proactive contact to raise awareness of domestic abuse, BWA services, enabling survivors to be referred to BWA support.

8. Publicise the work of BWA, delivering training to professionals and local community and faith groups on the range of BWA's service and ensuring other organisations know how to refer to BWA, supporting agencies to address the barriers faced by women from ethnic minority communities when accessing services.
9. Attend relevant events aimed at supporting or engaging clients from Black, Asian or Minoritised Communities.
10. Be an active member of the team, helping to cover the work of the team during absences, vacancies or when a colleague is under pressure, and liaising and coordinating with colleagues to provide an effective and cohesive service for clients. Share previous experience, skills and knowledge which may be relevant to the team in providing its service
11. Act as a specialist point of contact for the team, providing support and advice to other team members supporting clients from Black, Asian or Minoritised Communities and make BWA staff aware of cultural/religious events that are significant to their clients from Black, Asian or Minoritised communities.
12. Contribute to the strategic development and operational delivery of our high quality services for survivors and children from Black, Asian or Minoritised Communities who are escaping domestic abuse.
13. Keep up to date on local and national changes and best practice when supporting clients and issues that affect them.
14. Maintain accurate records in line with BWA procedures regarding all aspects of service delivery for monitoring and other purposes, including detailed case management records and the collation of statistics for quarterly reporting.
15. Ensure that the needs of all outreach clients are respected, especially those who face barriers to accessing services because of ethnicity, sexuality, disability or other hard to reach groups.
16. Work within and support BWA's policies and procedures, including maintaining confidentiality and professional boundaries across all of your work.
17. Be the voice of the clients and children we represent by ensuring that their experiences are accurately reflected and that complaints are dealt with via the BWA complaints policy.
18. Ensure that any safeguarding issues for children or vulnerable adults are raised immediately with BWA management as per BWA policies.
